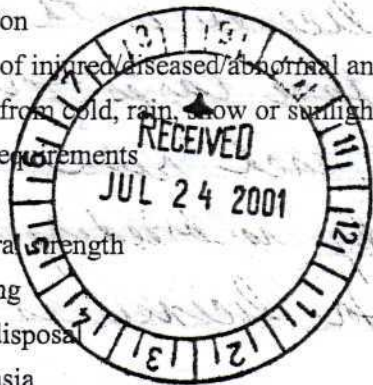

Patti McCarty. They informed me that they were once licensed with our office, but moved out of state for the past couple of years. They recently moved back to Ga., and were trying to complete their facility before contacting our office to be licensed.

1) The facility has (65) adult dogs (mix. pers., Boston terriers, dachshunds), but are kept separate according to species, sex, aggressiveness, etc. The county has an ordinance of (8) adult animals, but will allow more if they are licensed by our office. I will contact the Cherokee Cty. Marshall's Office and make him aware of this facility. However, this facility will apply for a license with our office today.

2) All pens have tarps for shade, and dog houses are provided in each run.

3) The facility is breeding/selling w/o a license, but application for license is being accepted today.
